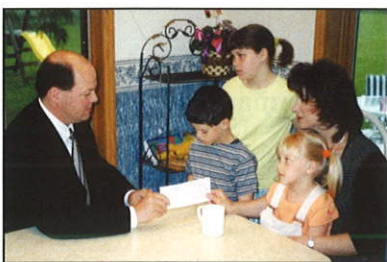
### **\$200 EMERGENCY CASH**

TMC will reimburse you up to \$200 for Emergency Room, Ambulance, X-Ray, Casts and Splints, Blood Transfusions, and Administration of Anesthesia.



### **\$40,000 CASH INCOME**

TMC will pay you, beginning the first day, \$100 for each day you are in the hospital or clinic up to 400 consecutive days.



### **\$10,000 DEATH/DISEMBLEMENT LOSS OF SIGHT BENEFITS**

TMC will pay your family \$10,000 as a result of injuries received in a covered accident for loss of life, any two limbs, both eyes. (Any one limb or one eye half benefits.)

## **\$100 EMERGENCY ROAD SERVICE**

TMC will reimburse you up to \$100 for a battery boost, fuel delivery, tire change, lock service, wrecker or towing service (with no mileage limit) by the commercial garage or wrecker service of your choice when the automobile, motor home, recreational trailer, or single rear axle truck you are driving or riding in becomes disabled.



## **\$600 TRAVEL ASSISTANCE**

TMC will reimburse you up to \$600 for car rental, meals, lodging, or commercial transportation when your automobile becomes disabled as a result of a traffic accident.



## **UP TO \$100 RENTAL REIMBURSEMENT**

TMC will provide vehicle rental reimbursement up to \$100 for up to three days of vehicle rental which becomes necessary in the event of a breakdown that renders your vehicle inoperable or unsafe to drive and is held overnight to complete necessary mechanical repairs at a commercial repair facility.

## **\$30,000 BOND**

TMC will provide up to \$30,000 bond to release you when you are accused of a moving traffic violation or automobile accident and charged with manslaughter or negligent homicide.



## **\$3,000 LEGAL FEES FOR YOUR DEFENSE**

TMC will pay your attorney up to:

- \$200 to represent you for a moving traffic law violation
- \$3000 when you are in an automobile accident and charged with manslaughter or negligent homicide



## **\$1,500 LEGAL FEES TO COLLECT/FILE**

TMC will pay your attorney up to:

- \$750 to collect or file for personal injuries when involved in an automobile accident
- \$750 to collect or file for automobile damages when your vehicle is struck by another automobile



## **\$2,000 STOLEN VEHICLE REWARD**
